

## Warranty for YUASA VRLA batteries

This warranty applies to sealed, maintenance-free lead-acid (VRLA) batteries.

Baterie Przemysłowe Sp. z o. o. ensures that the delivered batteries will be of good quality without defects in material and workmanship. Batteries advertised within the warranty period, will be at the discretion of Baterie Przemysłowe Sp. z o.o., regenerated, or replaced with new ones at no extra charge. This warranty covers defects only, created in the battery during the manufacturing process.

### Terms of warranty:

1. The battery will not be considered defective if its capacity within the period, warranty will not fall to:
  - 80 [%] of the rated capacity - for buffer operation.
  - 60 [%] of nominal capacity - for cyclical work.
2. Batteries working in parallel or series connection must be of one type series.
3. The warranty period will be reduced by 50 [%] for every 8 [°C] of permanent temperature increase, operation of the battery above the rated operating temperature of 25 [°C]
4. Each battery must be stored, charged, discharged. Operated in accordance with the written instructions contained in the data sheet and in, Quick Start Guide for Batteries.
5. Periodic maintenance should be performed at least every 12 months after installation, all batteries as recommended in the Quick Start Guide exploitation. Presentation of documented measurement results from each required periodic service is a condition for recognizing the complaint.

- damage caused by misuse or neglect;
- damage caused by force majeure.

The basis for recognizing the complaint is the presentation of the purchase invoice and delivery the advertised battery with the original marking of the serial number along with, description of the defect.

Warranty period - buffer operation:

- YUASA NP, NPH, NPW series batteries - 12 months from the date of installation, but not more than. 15 months from the date of delivery.
- YUASA NPL, RE, SWL, EN, ENL series batteries - 24 months from the date of installation but not more, than 27 months from the date of delivery.

Warranty period - cyclical work:

- YUASA NPC, REC series batteries - 12 months from the date of installation, but not more than 15 months from the date of delivery.
